Changes to the Laws of the Game

Law 4. Equipment

Players are responsible for the size and suitability of their **shinguards**.

Law 12. Fouls and Misconduct

Non-deliberate handball offenses for which penalties are awarded are to be sanctioned in the same way as fouls which are an attempt to play the ball or a challenge for the ball.

Law 14. The Penalty Kick

Part of the ball must touch or overhang the center of the penalty mark. Encroachment by players will be penalised only if it has an impact (same philosophy as goalkeeper encroachment)

This summary reflects some of the most common situations in BAYS matches. Full changes with interpretations/explanations can be found in the <u>2024/2025 IFAB Laws of the Game</u> as adopted by FIFA.

It is recommended that you encourage referees to download the IFAB Laws of the Game APP



Changes to the Laws of the Game

More details for the Law 12 changes

Cautions for unsporting behavior

- a player must be cautioned for unsporting behavior:
 - if they handle the ball to interfere with or stop a promising attack, except where the referee awards a penalty kick for a non-deliberate handball offense
 - If they deny the opposing team a goal or an obvious goal-scoring opportunity and the referee awards a penalty kick for a non-deliberate handball offense

Sending-off offenses

A player, substitute or substituted player who commits any of the following offenses is sent off for:

- denying the opposing team a goal or an obvious goal-scoring opportunity by committing a **deliberate** handball offense (except a goalkeeper within their penalty area)
- denying the opposing team a goal or an obvious goal-scoring opportunity by committing a non-deliberate handball offense outside their own penalty area

Further clarifications re: Denying a goal or an obvious goal-scoring opportunity (DOGSO)

- where a player denies the opposing team a goal or an obvious goal-scoring opportunity by committing a **deliberate** handball offense, the player is sent-off wherever the offense occurs (except a goalkeeper within their penalty area).
- Where a player denies the opposing team a goal or an obvious goal-scoring opportunity by committing a **non-deliberate** handball offense, and the referee awards a penalty kick, the offender is cautioned.



Assigning - Site Functionality

- Emails sent by clicking on blue envelope **automatically** CC in parent/guardian
- Other Official/4th referee slot available for all games
 - Town Paid Shows as \$0 rate since all towns will pay/use slot differently as mentors, trainees, field marshals, etc.
 - Assignment tracks through Referee Pay Download
 - Functions like another assistant referee
- Game Update Messaging
 - Free form text box for Assignors to use to send explanations/links/directions
 - to referees upon assignment changes
 - to referees AND coaches about rescheduling



Rearranged Games that Do Not Play as Scheduled

- Move games to <u>Unscheduled</u> as **SOON** as you know game will not be played
 - Publicly viewable on team's schedule page
 - Notification sent to coaches
- <u>Replacement Game(RG) Process</u> starts with the CR game report that game did not complete or kick off
 - Division Director makes Replay/No Replay decision that creates your RG
 - DDs may need prompting...
- Teams No Show MR 16
 - Starts with CR reporting Refs showed up but NO teams came to the field
 - Charged to the HOME team (responsible for canceling with home assignor)
 - \circ $\,$ Do NOT double process as LC $\,$
- Late Cancellation process
 - By Thursday at 7pm for Sat/Sunday;
 - By noon the day before for Weekday games
 - Keep the email you get as back up
 - Be sure who is responsible BEFORE you select:
 - Home/Away/50/50 split Fine assignment




BEFORE the GAME



Credentials











Anyone on the team sideline MUST wear their credentials in order to be on the bench with their team.

If a coach/official does not have their credential, the referee MUST ask them to go to the spectator side of the field.*

If they refuse to leave the bench politely, they are refusing an instruction from a match official.

The referee MUST ask them to leave again.

If they refuse a SECOND TIME, the referee should show a YELLOW CARD.

If they STILL REFUSE, the referee should show another YELLOW CARD, which will mean the coach is SENT OFF and must leave the field, and they will miss the next game too.

Law 5.3

Referee takes action against team officials who fail to act in a responsible manner and warns or shows a yellow card for a caution or a red card for a sending-off from the field of play and its immediate surrounds, including the technical area

*Note: there is one exception to this for certified deaf/hearing impaired interpreters.

Pre-Game Check-in Process

- 2 printed paper official rosters required
 - If only one printed, still okay if opposing coach agrees, and then they just take a picture
- Referee will check-in the players making sure their names are *printed* on the roster and they have unique jersey numbers
 - New BAYS request that jersey #s *should be printed* on official rosters by clubs
- Referee will check the players for safety:
 - (5 S's): shirt, short, socks, shin guards, safe shoes
 - No jewelry. None at all. Wearable item policy Cultural or medical items must be made safe.
 - No hard casts

Spectators

- Spectators must set up on one side of the field, teams on the opposite side. At least 5' off the touchline
- No one behind the goals or on the endlines.



New Guest Player Policy

BAYS Guest Player Policy is in effect for the Spring 2025 season.

How is the Playing Up Process at the Game Field Handled?

The following needs to occur when a coach uses a Guest Player in their game.

- 1. The coach must provide the referee at the field with **two paper copies** of their official game roster and **two paper copies** of any official roster(s) listing any Guest Player(s).
- 2. Coaches are responsible for making sure that all players playing in the current game are listed with a unique jersey number, across all rosters, prior to providing the rosters to the referee.
- 3. Coaches should write in the current Game ID# on all of the rosters handed to the referees.
- 4. The referee should give the opposing coach a copy of all the rosters provided. The opposing coach should keep these rosters.



Guest Players

- 1. **Assigned Team Roster**: All players on the assigned team roster who are NOT playing in the current game should be crossed out.
- 2. **Guest Player Roster(s)**: All players NOT playing in the current game EXCEPT the Guest Player(s) should be crossed out.
- 3. Referees must use the rosters to check the players in.
 - a. They should treat Guest Players meeting the above requirements as fully rostered and eligible for the match and report any issues or events related to those players in the same fashion as any other player in their game report. It is not the responsibility of the referee to verify that the guest players meet the policy requirements—That is the responsibility of the coach.



Guest Players

- 1. Referees must add to their game report (check a box for each team) that the Guest Player Policy was used to allow guest players to play in the game on a particular team. No names or other info needed.
- 2. Referees check-in players on the rosters provided. If the rostered players are questioned, it is the Division Director, or Grade Director, as needed, who will determine the outcome of the game.
- 3. Referees MUST keep all rosters for all games until the end of the season.



Pre-Game Sportsmanship Statement Purpose

Mass Youth Soccer and BAYS require that the Sportsmanship Statement listed below be read prior to ALL games.

This REPLACES the post-game handshake line. There were too many unfortunate incidents when teams interacted after heated games so the intention is to avoid that post-game interaction.



Pre-Game Sportsmanship Statement

Procedure

After all pre-game activities are complete, both teams and the referee crew will line up at the Half Way Line of the Coaches Sideline.

Led by officials, all players and coaches will walk across the field and line up facing spectators, 5 yard from the sideline.

The Sportsmanship Statement will be read by a **representative of the Home team** to all coaches, players and spectators.

Following the reading of the script, players will perform a pre-game handshake. (Home team to walk down the line of Away Team).

After the pre-game handshake, all players and coaches will return to benches and starting players will assume positions on the field of play.

Center Referees will check a box in their game report that Sportsmanship Stmt was read or not. Club will receive reports based on this Referees are not reading the statement

Pre-Game Sportsmanship Statement

Text the will be read:

Mass Youth Soccer and BAYS share a mission to provide a safe, fun, and inclusive soccer experience for all participants.

All participants deserve the right to play in an environment free from hostile and distracting behavior. Please do your part to create a positive soccer experience for all.

Poor sportsmanship will not be tolerated, and sanctions may be applied for violations of policy or codes of conduct.

It is the referee's discretion to terminate the game if any threatening or discriminatory statements are made or for anyone entering the field of play without permission.

Enjoy the game, have fun, and show respect for each other.



DURING the GAME





RESPECT THE CALL

The **PENALTY SUMMARY document**

is available on the Mass Youth Soccer website



- Protect and Support Referees and Better Soccer Environments
- Applies to all misconduct towards officials from participants.
- Stronger penalties to Coaches, Spectators, and PLAYERS
- Mass Youth Soccer policy extended sanctions to spectators
- Insulting, Belittling, Insinuating, or Taunting Behavior undermining referee classified as Gross Misconduct.
- Minor Multiplier results in Triple Punishment



PENALTY OVERVIEW

The Penalties Matrix defines consequences associated with physical and non-physical offenses against Referees.

(*) Disclaimer: These are only a few examples of abuse - other actions or statements may also fall into this category.

KEY PENALTY FACTORS

- Single offenses are at minimum the prescribed game penalty or time penalty for non red zone offenses
- Penalties can be **both game and time depending on severity** / circumstances
- Second time offenders receive **double punishment**
- Third time offenders receive a **lifetime ban**
- More than one offense at the same time is at least the punishment for the most serious offense
- Offenses against minors are automatically subject to **a "minor multiplier" resulting in triple punishment**
- One offense warning per league to be managed by states and leagues collaboratively
- Game consequences are **inclusive of 1** game penalty for any red cards given
- Optionality for **50% penalty for first** offense from a minor

Please follow your current reporting structure - updated reporting procedure will be a part of Phase 3.





NON-PHYSICAL ABUSE

Contact doesn't have to be made for damage to occur. Non-physical abuse – hurtful language and aggressive behavior – has no place in our game. It disrupts matches, interferes with the referee's ability to do their job, and it hurts the game for everyone. Left unchecked, non-physical abuse takes an emotional toll and has the potential to escalate into physically dangerous situations. The updated policy is designed to eliminate this behavior.





LEVEL 1: VERBAL TAUNTING

Speech or gestures intended to belittle the referee, damage their credibility, and undermine their ability to effectively officiate the game.

DEFINITION

Insulting, Belittling, Insinuating or Taunting Behavior Undermining Referee Authority.

EXAMPLES

- Questioning Competence: "Do you even know the rules?"
- Mocking Appearance or Abilities: "Did you forget your glasses?"

Accusations of Bias:
 "What's the other team paying you?"

- Dismissive Language: "You suck."
- Aggressive Tone:

"You're the worst ref we've ever had."

RECOMMENDED APPROACH

If you have concerns about a call, respectfully ask the referee for clarification. Share your perspective calmly, avoiding yelling, insults, or offensive gestures.

Disclaimer: These are only a few examples of abuse – other actions or statements may also fall into this category.



BAYS limits the items that can be "clarified" Coaches may ask questions before the start of the game. Coaches may not approach the referee at half time or at the end or after the game except to:

- Respond to an Official who has initiated a conversation
- Point out emergency or safety issues
- Call for substitutions
- Ask the Officials to clarify ONLY: type of restart/direction of throw-in or indirect vs. direct free kick
- Ask for the time remaining in the half

LEVEL 2: HARASSMENT/INTIMIDATION

Occurs when language or body language is intended to make a referee feel unsafe but where the threat of violence remains unspoken.

DEFINITION

Harassment, Intimidation, Retallation, Abusive or Threatening (Non-Physical) Language.

EXAMPLES

Using Expletives: "That call was complete \$H*t!"

Personal Attacks:
 "You're a F-ing joke!"

Escalating Intensity: "You can't make a single good f****** call!"

Getting In The Referee's Face.

RECOMMENDED APPROACH

Take a moment to gather yourself before you speak to the referee. Ask for clarification calmly, aiming for constructive communication rather than causing conflict.

Disclaimer: These are only a few examples of abuse – other actions or statements may also fall into this category.



BAYS limits the items that can be "clarified"

Coaches may ask questions before the start of the game. Coaches may not approach the referee at half time or at the end or after the game except to:

- Respond to an Official who has initiated a conversation
- Point out emergency or safety issues
- Call for substitutions
- Ask the Officials to clarify ONLY: type of restart/direction of throw-in or indirect vs. direct free kick
- Ask for the time remaining in the half



LEVEL 3: THREATS/DEROGATORY LANGUAGE



When aggressive language or threats of violence enter the mix - or when abuse spills online.

DEFINITION

Aggression, Attacking, Derogatory, Cyberbullying, Doxing, or Threatening (Physical / Violence) Language.

EXAMPLES

- Threatening To Inflict Harm On A Referee:
 - "You're gonna pay for that!"
 - "I'll see you in the parking lot"
 - "I'm going to shove that card down your throat!"
 - "You better watch your back!"
- Public Attacks Online such as uploading a post to social media attacking the referee.

RECOMMENDED APPROACH

When you feel frustrated by a referee's call, take a moment to pause and breathe. Reflect on how your reaction impacts your experience and the overall atmosphere of the game for everyone involved.

Disclaimer: These are only a few examples of abuse – other actions or statements may also fall into this category.





LEVEL 4: OFFENSIVE OR DISCRIMINATORY ACT



U.S. Soccer is inclusive of everyone. Discrimination - attacking referees for who they are, or offending their dignity - will not be tolerated.

DEFINITION

Discriminatory or derogatory words or actions on account of race, skin color, ethnicity, nationality, social origin, gender, disability, sexual orientation, language, or religion.

EXAMPLES

- Racial or ethnic slurs.
- Offensive gestures.
- Homophobic language.
- Using harmful or sexist stereotypes.

RECOMMENDED APPROACH

Remember that soccer is for everyone. We're all human, and everybody deserves the opportunity to enjoy the game without being made to feel bad about who they are.

Disclaimer: These are only a few examples of abuse – other actions or statements may also fall into this category.







Physical abuse makes the game unsafe for everyone. It's also easy to avoid. Outside of friendly handshakes, there's never a reason to touch the referee. Any unwanted physical contact is considered physical abuse. Physical violence can also result in criminal charges, lawsuits, or medical liability.



LEVEL 1: MINOR OR SLIGHT TOUCHING



Even minor deliberate touches can be unwanted and make referees feel unsafe and are considered physical abuse.

DEFINITION

Minor or Slight Deliberate Touching.

EXAMPLES

- Tapping the referee's shoulder to get their attention.
- Touching the referee's chest with your finger.
- Grabbing the referee's jersey to get their attention.
- Intentionally bumping lightly into the referee.

RECOMMENDED APPROACH

Respectfully get the referee's attention without touching them – and, even in the heat of the moment, make a conscious effort to keep your hands to yourself.

Disclaimer: These are only a few examples of abuse – other actions or statements may also fall into this category.





POICY 531-9 PHYSICAL ABUSE LEVEL 2: INTENTIONAL CONFRONTATION



Escalation of using contact to intimidate or provoke a physical confrontation - or causing damage to property - without the intent to cause bodily harm.

DEFINITION


Pushing, Grabbing, Pulling, Squeezing, Pinching, Lightly Slapping, Use of Object in Non-Striking Manner, or Physical Property Damage

EXAMPLES

- Shoving the referee.
- Forcefully grabbing the referee's arm.
- Throwing a water bottle at the ground in front of the referee.
- Dumping the referee's bag into a trashcan.
- Aggressively grabbing the referee's jersey.
- Following the referee to the parking lot or to their car.

RECOMMENDED APPROACH

Understand that this behavior not only won't change the outcome on the field, it will keep you out of the game for a long time. Channel that energy to drive better on-field performance. Remove yourself from the situation if you need to calm down.





LEVEL 3: VIOLENT CONTACT



Malicious, violent contact intended to cause bodily harm - this is considered assault and can result in criminal punishment, legal suits, and medical liability.

DEFINITION

Hitting, Punching, Elbowing, Kicking, Biting, Spitting, Choking, Tackling, Throwing or Use of Object or Any Part of Body (Forearm, Knee, Head) in a Striking Manner

EXAMPLES

- · Kicking the referee's shin.
- Throwing a punch at the referee.
- Placing hands on the neck to choke the referee.
- Throwing a water bottle with intent to hit the referee.
- Intentionally kicking the ball at the referee.

RECOMMENDED APPROACH

Before physical abuse ever escalates to this level, there are plenty of opportunities to choose another course of action. Remove yourself from the situation and give yourself time for your anger to defuse before doing something with serious long-term consequences.

Disclaimer: These are only a few examples of abuse – other actions or statements may also fall into this category.







Verbal/Physical/Sexual Misconduct

When any misconduct, not directed at the referee, occurs or is reported



The REFEREE MUST STOP the GAME



Observed/Heard by Referee Crew

If a member of the referee crew witnesses or hears that a player or coach is being subject to derogatory language or discriminatory actions, the incident should be addressed according to the IFAB Laws of the game.

Reported to Referee Crew


If a member of the referee crew did not hear or witness directly but a player or coach reports the incident to the referee, the Center Referee should implement the following steps:

- Stop the game, if necessary, or use stoppage in play.
- Send both teams to their respective technical areas.
- Gather the referee team.
- Bring both coaches together.
- Explain the situation to the best of your ability and understanding.
- Direct the coaches to resolve the issue immediately.
- Resume the game if issue is resolved
- If the coaches are uncooperative, or a resolution cannot be initiated or reached in a reasonable amount of time (resolution not to exceed 5 minutes), the referee will abandon the game immediately.



Derogatory Language and Discriminatory Actions include but are not limited to:

- Discriminatory or derogatory words or actions based on race, skin color, ethnicity, nationality, social origin, gender, disability, sexual orientation, language, or religion.
- Sexually explicit statements, sexual flirtations, advances, propositions, subtle pressure for sexual activity, comments, questions, jokes, or anecdotes.
- Jokes or gestures that include reference to race, skin color, ethnicity, nationality, social origin, gender, disability, sexual orientation, language, or religion.

Suspensions

for Verbal/Physical/Sexual Misconduct

for Referee Abuse Prevention (RAP)

Anyone asked to leave the game field as a result of either policy must remain

100 feet from the field or in the parking lot whichever is farthest from the field.

Anyone suspended who comes to the game field must remain (e.g. a parent bringing a player to the game)

100 feet from the field or in the parking lot whichever is farthest from the field.



AFTER the GAME



NO Post-Game Handshake

REFEREES are not to supervise a handshake line after the game.

REFEREES do not need to stop teams doing the handshake.

REFEREES do NEED to watch as the teams pack up to leave, especially if they do an unsupervised handshake.
