## **Executive Committee**

The role of the BAYS Executive Committee is to help the Board accomplish its work in the most efficient way.

The BAYS President, all elected Vice Presidents, Treasurer, Secretary, Immediate Past President, Registrar, Scheduler, Grade Directors, Referee Director(s), and Ejection Director are members of the Executive Committee. The President may include additional directors to attend Executive Committee meeting(s), but in the event of any Executive Committee vote, the guest director may not vote.

The Executive Committee is able to make emergency decisions, subject to the constraints of existing BAYS policies, on behalf of BAYS when the convening of a meeting of the full Board of Directors is not possible or practical. Any actions that take place as a result of an Executive Committee vote must be disclosed to the full BAYS Board of Directors as soon as practicable, but not more than three days after, and then presented at the next Board meeting.

Here is what a Grade Director is responsible for within a Grade Group. Therefore, Grade Directors would be a valuable addition to the Executive Committee's primary role of making the BAYS Board accomplish its work in the most efficient way.

- Work across the Division Directors assigned to the grade group to ensure consistent application of BAYS policies and rules.
- Mentor Division Directors, particularly new ones, and be available to answer questions or provide direction on whom to contact in BAYS to provide the needed information.
- Facilitate the development of swap candidates across Division Directors' responsibilities to try to improve the experience for all teams.
- Execute swaps within the grade group once proposed and vetted by the lead Division Director.
- Be aware of lopsided scores and game incidents within their grade
- Participate on any Sportsmanship Review Committee needed for a team within the Grade Director's group.
- Help with team placement activities by reviewing proposed placements and suggesting changes as needed.
- Participate on Placement Committee
